Craig Gosen wants us to just give the Fire dept a couple hundred thousand dollars from the general fund, instead of increasing the millage he also objected to the time of the meeting.

Art Peters doesn't think increasing the assessment is justified, he feels we misunderstood the sentiment of the residents.

• Recognized Craig Gosen Discussion ensued on water dist #1 budget Craig pointed out that the bond needs to be reamortized whenever we make an extra payment. Principle stays level and interest goes down , rural development does the reamortization. 12:50 comments closed.
