SPECIFICATIONS:

Edenville Township is accepting bid proposals for the demolition, removal, and clean-up of a burned mobile home located at the above address. The work includes the removal of the mobile home and only the debris on the property associated with the fire scene. Structures **NOT** to be removed are the tan and gray sided with white and brown trimmed detached shed to the immediate east of the home and the small white sided with black roof pump house to the east of the large tree on lot, to the northeast of the home. The contractor performing the work is responsible for ensuring all utilities, including but not inclusive to, gas, electricity, water lines, and telecommunications are safely removed before beginning the work.

Final inspection after completion will be done when ground is clear of snow.
Proposals should include a completion of date.

VENDOR COMPLIANCE

The Township of Edenville requires bidders to submit documentation indicating they are licensed in the State of Michigan to perform the work recommended.

INDEMNITY

The Contractor shall, at Contractor's own expense, protect, defend, indemnify and hold harmless Edenville Township, and its officers, employees, agents, or representatives, from and against all claims, damages, liabilities, losses and expenses, including reasonable attorney's fees, resulting from the acts, omissions, or negligence of the Contractor, or any of Contractor's officers, employees, agents, representatives, or subcontractors, in any way connected or otherwise related to their performance or nonperformance of this Contract.

EVIDENCE OF BIDDER'S QUALIFICATIONS

Bidders may be required to submit satisfactory evidence that they have been regularly engaged in the business and are reasonably familiar therewith, and that they are fully prepared with the necessary capital, materials, and machinery to complete the work.

TRANSFERS PROHIBITED

The assignment or transfer of any contract, or interests in the contract are prohibited unless approved by Edenville Township.

INSURANCE

Certificates of insurance are required to be turned in to the Township Clerk. It is the responsibility of the insured contractor to confirm proofs of insurance are on file with the Township.

FORMS OF BIDS

1. Bids submitted in response to this notice shall be submitted in ink or typewritten.
2. Bids must contain the bidder's name, address, and telephone number. Email is desired.
3. Bids must be signed in ink and dated.
4. Any addendum must be signed, dated and returned with bid.
5. All erasures or corrections must be initialed in ink.
6. All bids must be submitted to the Township Office by the date and time specified on the solicitation.

Edenville Township reserves the right to accept or reject any and all bids, or parts thereof. Any rejection of bids will be made only if there is a sound and documented reason.
