Gosen called the meeting to order at 6:00 p.m. and the pledge of allegiance was recited.

#### ADDITIONS/DELETIONS/CHANGES/CORRECTIONS TO THE AGENDA:

Schultz motioned to approve the agenda as presented, Sperling seconded and after a voice vote the agenda was approved as presented.

#### MOTIONS BROUGHT BEFORE THE BOARD:

**Resolution 2019-13 setting the Treasurer's salary:** Draves motioned to approve Resolution 2019-13 setting the Treasurer's salary at \$17,115/yr. + \$4,000/yr. for summer tax collection for fiscal year ending June 30, 2020. Schultz seconded and the motion carried via roll-call vote.

**Resolution 2019-14 setting the Supervisor's salary:** Carey motioned to approve Resolution 2019-14 setting the Supervisor's salary at \$14,615/yr. for fiscal year ending June 30, 2020. Sperling seconded and the motion carried via roll-call vote.

#### Resolution 2019-15 setting the Trustee's salary:

Gosen motioned to approve Resolution 2019-15 setting the Trustee's salary at \$5,000/yr. for fiscal year ending June 30, 2020. Carey seconded and the motion carried via roll-call vote.

#### Resolution 2019-16 setting the Clerk's salary:

Sperling motioned to approve Resolution 2019-16 setting the Clerk's salary at 17,115/yr + 4,000 for election administration for fiscal year ending June 30, 2020. Schultz seconded and the motion carried via roll-call vote.

#### **BUSINESS DISCUSSIONS:**

#### Private Road Maintenance Special Assessments:

Gosen – Reviewed the proposed private road maintenance special assessments for following areas with the only change being Lakeview Subdivision which will increase from \$39.39 per parcel to \$40.63 per parcel. Bluff Creek (Ginger Dr.) – no change; Campbell Ct. – no change; Fox Rd. (North end of Fox Rd.) – no change; Lakeview Subdivision (Wixom, Beach and Dorr) – slight increase (due to two parcel

combinations); Sanford Lake Estates (Enchanted Forest and Lake Forest) – no change; and Woodland Estates (South end of Fox Rd) – no change.

#### PUBLIC COMMENTS on the private road maintenance special assessments: None

#### Fire Department Special Assessments:

Gosen – The FD Special Assessment of 0.75 mils for operations and 0.65 mils for capital improvements and equipment will remain the same with no change from last year.

#### **PUBLIC COMMENTS** on the fire department special assessments:

Roger Dufresne asked if there is a chance that someday the special assessment will be increased. Gosen replied that it can be increased as necessary.

#### **Lake Weed Special Assessment:**

This assessment is not on the agenda because we have a Public Hearing on September 5<sup>th</sup> to re-establish the Lake Weed Special Assessment. There will be a special hearing notice printed in the Midland Daily News and the residents in the Lake Weed Special Assessment District will be notified.

#### PUBLIC COMMENTS on the lake weed special assessment: None

#### Township Board Salaries:

There is no change for Supervisor, Treasurer, and Trustees, and Clerk will increase from \$17,115 to \$21,115 (for election administration).

#### Township Operating Millage:

Gosen, the millage will remain at 1.1017 (no change from last year).

<u>General Appropriations Act (19/20 Budget)</u>: Gosen presented the General Appropriations Act setting the budget for the 2019-2020 Fiscal Year.
