- Invocation—given at 5:27pm.
- Meeting called to order at 5:30pm by T.Hall; pledge to the flag
- Township Board attendance by roll call (verifying quorum):

- Approval of agenda with changes:
 - J.Sperling moved to add retreats coming up in October; County Township Association meeting on the 16th to be included—both under New Business. A.Lewis seconded. Voice vote. Motion passed unanimously.

 - C.Starkey moved to add changes and deletions; C.Starkey will make changes and re-submit revised Minutes. J.Sperling seconded. Voice vote. Motion passed unanimously.

 correction will be made regarding Trustee pay.

- Jason Lafave 4757 N. Water Rd.—would like to discuss the complaint process and lack of follow-up with the complaint filed. The complaint is in regards to the uncut trees as well as single family dwelling requirements—see Article 4. Friday before Labor Day, chased and bitten by one of their unleashed dogs.
- O Carol Service 916 Gennessee—neighbors with significant trash at 920 Gennessee—behind the house and the garage is filled trash/junk. Residents are not living there; rather, picking up trailers of trash and taking it there; actually live on Coleman Road in Coleman. Another problem exists at 919 Gennessee, where yard is full of trash, broken windows covered by blankets. Trash extends into the ditches and beyond property lines. Just as bad as before the dumpster was brought there. No electricity because Consumers cut them off; they tapped into electricity next door; goat living in the house as well.
- No name or address given: same problem with 6355 N. Water Rd. living in campers, cars are not drivable, digging holes next to the road. There are people in and out of there, parked on the side of the road. If we aren't going to enforce the Township rules for them, then

- when we build our pole barn no one had better say we can't. I have also submitted a complaint, and nothing has been done.
- Jason Lafave: So, what happens with this? We have filed written complaints, we have come here to speak. Nothing has been done.

 - R.Dufresne: we are going to need a new pumper in the next 4-5 years. Had ours re-serviced because a new one is in the ballpark of \$400,000.

 - Parks and Recreation Committee Mary Beth Seasholtz
 - Five Year Parks and Rec Plan:
 - Harper Park JBS Quote approved last month minus the staining

- A.Lewis: deposit has been paid, nothing scheduled yet
- MB.Seasholtz: quote coming for staining from Edgar Co.
- Howden cleaned weeds at Harper Park; when contracts come due, consider building-in a grounds care portion to be added to our contract
- A.Lewis: currently soliciting bids
- Bike Rack: Installing a secure bike rack in at Harper Park
 - Asking for approval of up to \$400 to purchase and install the bike rack. Use Metro Funds to do this?
 - K.Carey: Not sure the Metro money would pay for a bike rack.
 - o T.Hall: What line item will it come out of?
 - Table this discussion until October Twp Meeting;
 MB.Seasholtz will bring bids, documentation
- No cigarette receptacle at the Board Room entrance at Swanton Hall. Recommend the Board purchase one for this location.
- Five-Year-Plan: conduct a survey-- online survey, currently ready. Recommendations on how it should be dispersed:
 - Website; ad in the newspaper; try to get it on the Midland County Parks website; posters to be placed around the Township; facebook; also have a .pdf file of the survey as well as paper copies.

- Water District No. 1 Terrance Hall / Craig Gosen
 - Bulk Water rates have increased .03 cents per thousand gallons
 - C.Gosen: City can raise it every year, but they haven't, so
 we are in good shape. Ron Rose will be retiring in the
 next 1-2 years; hoping to bring someone new on to train
 prior to his retirement.
 - Edenville Water Tower inspection went well; minor repairs. Is inspected every 5 years.
 - Water District received FEMA funds, which helped fund meter replacements, repairs, and other projects.
- Seven-minute recess called back to order at 6:35pm
 - Ordinance Enforcement- Terrance Hall
 - T.Hall: we have had an astronomical number of total complaints; T.Hall requests A.Lewis to bring a total number of complaints by address to next meeting. Complaint process is posted on the Twp website; follow-through process further described by T.Hall. Ordinance Officer investigates, determines if violation has occurred, decides on action (if any) to be taken. Thirty days of grace given to correct citation; after 30 days, if not rectified, civil violation/court is pursued. If they are found guilty, they are fined/jail time, otherwise, charges dropped. If they are fined/serve time, they are given a timeframe to address that. Complaints are logged and given a complaint number in the system.

- Ordinance Enforcement Report: Reviewed complaint 21-35, finding no violations of Township Ordinances, the complaint is to be filed closed.
- West Side Report: Gennessee, Ingham, Telegraph: Township has historically fielded complaints from this area of the Township.
