    - Water District is not party to any use of ARPA funds.
    - The Water District would purchase all five parcels and then sell three parcels to Edenville Township.
    - Water district is not part of the restroom aspect
    - This is not a joint venture—the Water District is going to purchase the whole block and then sell three parcels to the district. WD1 will take ownership of lots 4 & 5 and then sell to the Township lots 1, 2, and 3.
    - Motion to approve Resolution 2021-21 made by T.Hall, seconded by K.Carey. Updated copy with all of the changes will be sent.
